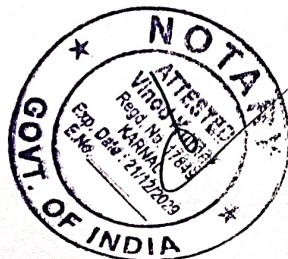




I, Narinder Kumar resident of hereby affirm and declare as under:
I am the Secretary school MAHARISHI DAYANAND
SHIKSHA SAMITHI society. SH. Sec. School run by M. H. H. R. S. H. I. DAYANAND
V. Ballabh (Karnal)

1. That the grant for recognition les not extendable and does not in any way imply any obligation to recognize affiliate beyond Class VIII
2. That the school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. That the school shall ensure that:-
 - (1) The school shall admit in class 1, to the extent 25% of the strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free sad compulsory elementary education till its completion:
 - (i) provided, that in case of pre primary classes also, this noun shall be followed.
 - (ii) The school shall admit in class 2nd to 8th under rule 134-A to the extent of 10 % of the strength of that class for meritorious students belonging to economically weaker section.
4. That for the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section" 12. To receive such reimbursements school shall provide a separate bank account
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. That the school shall not deny admission to any child for lack of age proof If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of bath or any of them.
7. That the school shall ensure that 1-
 - (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school
 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.
 - (iv) every child completing elementary education hall be awarded a certificate as laid down under rule 22;
 - (v) Inclusion of students with disabilities/special needs as per provision of the Act
 - (vi) the teachers see recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5
 - (vii) the teacher performs its duties specified under section 24(1) of the Act and
 - (viii) the teachers shall not engage himself or herself for private teaching activities.
8. That the school shall follow the syllabus on the basis of curriculum laid down by academic authority.
9. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.

10. That the school shall maintain the standards and norms of the school as specified in section 19 of the Act. The facilities reported at the time of last Inspection are as given under:-

- (v) Separate toilet for boys and girls

- (ix) Availability of Teaching Learning Material /Play Sports equipment / Library

11. That no unorganized is shall run within the premises of the school or outside in the same name of school.

12. That the school buildings or other structures of the grounds are used only for the purposes education and skill development.

13. That the school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under say law for the time being it force

14. That the school should be audited and certified by s Chartered Accountant and proper should be accounts statements should be prepared se per rules A copy of the statements of accounts cats sent to the District Elementary Education Officers every year

15 That the recognition code Number allotted to your school is This may please be noted and quoted for any correspondence with this office.

16. That he school furnishes such reposts and information as may be required by the Director of of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be Issued to secure the continued fulfillment of the condition of recognition of the deficiencies in working of the school.

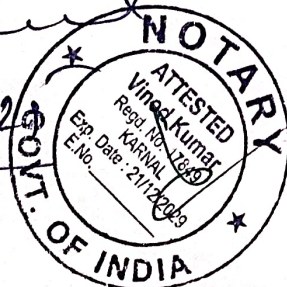
